



Liability Waiver

Every Player must sign/acknowledge The House Athletics liability waiver/roster to be eligible to play.

The undersigned acknowledges that the undersigned's participation in **The House Athletics** events is voluntary. In consideration for the undersigned's participation in **The House Athletics** events, the undersigned on his or her own behalf and on the behalf of his or her heirs, executors and assigns does hereby agree to assume all the risks and responsibilities surrounding such participation and does hereby also fully and forever waive, release and discharge **The House Athletics**, and their respective officers, directors, employees and agents (collectively, the "Releasees") from any and all liabilities, demands, claims, damages, losses, costs (including attorneys' fees), actions and causes of action (known or unknown) arising out of or related in any way with the undersigned's participation in **The House Athletics** events or presence at any **The House Athletics** events at any time, including, but not limited to, any claim whatsoever on account of first aid or service rendered to the undersigned during **The House Athletics** events. This release is intended to discharge in advance the Releasees and all other parties and properties related with **The House Athletics** events from liability to the full extent allowable under applicable laws, EVEN THOUGH LIABILITY MAY ARISE OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF THE PERSONS OR ENTITIES MENTIONED ABOVE.

The undersigned further agrees that this release is a full and complete waiver of all claims, which shall apply to all known and unknown and unanticipated claims, and waive the benefits of Section 1542 of the California Civil Code, which provides that "a general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release which if known by him or her must have materially affected his settlement with the debtor." The undersigned agrees that under no circumstances will the undersigned or his or her heirs, executors or assigns prosecute or present any claim for personal injury, property damage or wrongful death against the Releasees arising out of or related in any way with the undersigned's participation in **The House Athletics** events or presence at **The House Athletics** events at any time, whether as a result of the Releasees' negligence or otherwise.

INDEMNITY: The undersigned agrees to fully and forever indemnify, defend and hold harmless the Releasees from any and all liability, including any and all demands, claims, damages, losses, costs (including attorneys' fees), actions and causes of action (known or unknown) arising out of or related in any way with the undersigned's participation in **The House Athletics** events or presence at **The House Athletics** events at any time, including, but not limited to, any injury, property damage or death that the undersigned may suffer as a result of the undersigned's participation in **The House Athletics** events, REGARDLESS OF WHETHER THE INJURY, DAMAGE OR DEATH IS CAUSED BY THE NEGLIGENCE OF ANY OF THE RELEASEES OR OTHERWISE.

The undersigned has read this document and fully understand its terms. The undersigned understands that he or she may be giving up substantial rights by signing this document and signs it freely and voluntarily without any inducement. It is further understood and agreed that this Release and Waiver of Liability must be signed to participate in **The House Athletics** events and that it is legally binding on the undersigned and his or her heirs, executors and assigns.
